#### Minutes of Regular Meeting Board of Commissioners October 14, 2019

Board Members Present: Joe Hand, Stephen Rosenthal, Leslie Sturmer, Dottie Haldeman (left at 6:00p.m.), and Chris Reynolds (arrived at 5:10 pm).

Others Present: John McPherson, Mandy Offerle, Shrader Miller, Maureen Magee, Steve Priessman, Diana Priessman, Jim Wortham, Mandy Offerle, Frank Offerle, Mike Allen, Mendy Allen, Jim Mason, Nicki Mason, Jerry Treat, Bob Treat, Sue Colson, Maurice Hendrix, Janice Hendrix, Andrew Gude, Larry Schmidt.

- 1. Meeting called to order at 5:00 p.m. by Stephen Rosenthal, Chair.
- 2. Pledge and Prayer.
- 3. Adoption of Agenda. **Motion** by Leslie Sturmer to adopt the agenda as presented. **Second** by Dottie Haldeman. Passed by a vote of 4-0.
- 4. Public Input. Steve Priessman made a presentation regarding cell service in Cedar Key, a written version of which is attached to these minutes. Other comments included:
  - Sue Colson: Cell phone coverage is terrible at Cedar Key School which creates a dangerous situation. A solution needs to be found. A more formal group needs to be created to meet regularly and work on a solution. CKWSD, the school and the Sheriff need to be involved in this group, and possibly rural health representatives. She said the City could provide space for such meetings, but it should be the citizens who move this forward. There is the problem of low population in the rural areas making it difficult for cell phone companies to be profitable in these areas.
  - Jim Worthan: Need to include AT&T and other carriers in the discussions, not just Verizon. Public safety should be the motivating goal rather than maximizing revenue from the cell companies.
  - Dottie Haldeman: Stated that the District has been working will tower companies and cell phone carriers over the years to try to improve cell service in town. She agreed that the lack of coverage at the school created a public safety issue that needed to be addressed.
  - Steve Priessman: Reviewed the funding options that he has researched and is pursuing.
  - John McPherson: Went over the history of the District's relationship with American Tower and NexTower, and noted that the District has always been, and continues to be, open to use of its property as a possible location for towers and/or antennas.
  - Leslie Sturmer: There should be a public workshop on the issue, to include the key players and the interested citizens at the meeting.



- Mandy Offerle: Offered to send out an email to the group attending the meeting as a
  way to start the process of creating a more formal group that meets regularly on this
  issue.
- 5. Approval of Minutes. **Motion** by Dottie Haldeman to accept the minutes of the regular meeting on September 9, 2019, and the final budget hearing on September 23, 2019. **Second** by Joe Hand. Passed by a vote of 5-0.
- 6. Financial Reports. Budget, Balance Sheet, Checkbook Activity, Past Due Accounts, and Employee Leave reports were presented for review. The General Manager was asked to check with Away From the World about its high bill. **Motion** by Leslie Sturmer to accept the financial reports as presented. **Second** by Dottie Haldeman. Passed by a vote of 5-0.

#### 7. Bill Adjustment Requests:

- Betty Cooke for an adjustment from \$132.53 to \$97.00 due to hose on dock being left on.
- Diana Bible for an adjustment from \$165.91 to \$119.13 due to broken exterior pipe.

Motion by Dottie Haldeman to approve the requests by Betty Cooke and Diana Bible. **Second** by Joe Hand. Passed by a vote of 5-0.

#### 8. General Manager Report.

- a. Water Plant. The GM reported that the chlorine dioxide test is on hold due to continuing problems with analyzers, and that the test will resume as soon as the problem with the analyzers is corrected.
- b. Wastewater Bridge Lines Directional Drills. The GM reported that construction began on August 5 and the three drills and associated work have been successfully completed.
- c. Downtown Building Painting and Repairs. The GM reported that the painting and repairs to the downtown building have been satisfactorily completed. Quotes and samples for new aluminum railings for the front of the building, and for a location in the WWTP where they are needed for safety, have been requested.

#### d. Contract with CRI

The GM reported that CRI accepted the lower price for auditing services and the contract has been executed.

e. Contract with John K. McPherson, P.A.

The General Manager presented a revised contract with John K. McPherson, P.A. for legal and general manager services showing the new monthly rate for 2019-2010. **Motion** by Leslie Sturmer to accept the contract as presented. **Second** by Joe Hand. Passed by a vote of 4-0.



#### Saturn Ion

The GM reported that pursuant to the recently approved budget, the 2007 Saturn Ion needs to be declared surplus by the Board, with direction provided as to method of sale. The GM provided information showing the retail value of the Saturn to be \$3,000 or less. Motion by Chris Reynolds to declare the Saturn Ion surplus and to place it on the market for \$3,000. Second by Leslie Sturmer. Passed by a vote of 4-0.

#### (Speaker's Notes)

I'm here to talk on a subject that the Cedar Key Water & Sewer District has been working diligently on for several years. As you may know, I had the privilege of speaking before the State Legislative Delegation in Bronson a few weeks ago. My remarks focused on cellular telephone service in Cedar Key. This is a bit of what I told Senator Rob Bradley, Representative Charlie Stone and an assortment of Levy County officials......

I'm here to share a citizen's perspective on cellular telephone service in Cedar Key. To do that, I need to re-introduce you to a device that we're all familiar with - the wireless cellular phone. That cell phone in your pocket or purse:

- Allows us telephone, text and email our friends and family
- Affords the opportunity to share experiences on social media
- Permits us to view news and weather forecasts
- Helps us pay our bills and monitor our finances
- Enables our connection to colleagues at work and fellow parishioners in our church
- Provides television entertainment, movies and music
- Gives us the ability to order from Amazon to conduct commerce on a global scale for economic benefit
- Monitor our health and communicate with our health care professionals
- Connects us with government and public service agencies
- Notifies us of important emergency announcements
- Guarantees our ability to connect with first responders
- Helps us protect our children at home and at school
- Saves lives by allowing us to access 911 emergency services

Yes, your cellphone is an amazing device. Because of its ability to offer a broadband connection to the internet, this device is your telephone, your newspaper, your radio, your television, your library of favorite books, your filing cabinet for important documents and more. Your cell phone can provide those capabilities for itself and it can power all the same broadband connections to devices throughout your home. Best of all, that connectivity is portable. That means you can take your connection with you wherever you travel, across town or around the world.

According to The United States Department of Health and Human Services, this cellular phone has become the only communications device for more than half the households across the country.

The US Department Health and Human Services also tells us 66% of kids in this country live in a home that doesn't have a land line telephone. We all remember land line phones. That's the phone with a cord, attached to a wire that comes from a telephone pole in the alley. The kind of phone that you are I have used throughout our lives. Today, 66% of the kids in this country (that's  $2/3^{rd}$  of the children in the United States) live in a home that doesn't have a landline phone. They rely exclusively on one of these wireless cellular phones.

I told Senator Rob Bradley, Representative Charlie Stone and all those Levy County officials that me and my neighbors in Cedar Key... we're just like the rest of the country...... We've all got these wonderful cellular phones.

For us in Cedar Key, there's only ONE THING this wireless cellular device DOESN'T DO......

This wireless cellular phone doesn't RELIABLY WORK in Cedar Key.

We should not be content to live in an area that lacks reliable cellular telephone service. Living in Cedar Key without the benefit of reliable cell phone service puts our community's public safety and our very lives at risk.

There are 2 challenges that must be addressed to provide a solution to the problem of reliable cell phone service.

The challenge of ECONOMICS

The challenge of GEOGRAPHY

The economic challenges faced by cellular telephone providers has largely been ignored until now. Here's the math: 300 to 500 households on our island yields 1,000 residents. Those 1,000 residents each having 2.5 wireless devices means 2,500 billable connections on the island. That's cell phones, iPads, computers and computer networks, credit card machines, cash registers, the ATM at the bank, those new electronic handheld waitress order pads at the 2<sup>nd</sup> Street Café and that fancy doorbell you installed that uses your cell phone to show you a picture of who is at the front door. The revenue from 2,500 devices doesn't provide enough profit for Verizon or AT&T or Joe's Pizza and Cell Phone Company to invest in the infrastructure improvements necessary to provide reliable service in Cedar Key.

We are not ignoring the economics. We are working diligently on both the State and Federal levels to secure funding subsidies to close the economic gap for cellular service providers. We're exploring grants and loan guarantees by leveraging the needs of our island's largest industry, Aquaculture. Know that funds have been earmarked to support Aquaculture and "rural" communities like Cedar Key. There are funds available to us both in Tallahassee and in Washington D.C. We are pursuing that money to help solve the challenge of ECONOMICS for reliable cell phone service in Cedar Key.


I'm calling on the Cedar Key Water & Sewer District Board to partner with the citizens of Cedar Key to solve the challenge of GEOGRAPHY.

#### Here are the details:

To supply a reliable cellular telephone connection, the provider's cellular transmit/receive antenna array must meet 2 requirements.

- 1. The cellular transmit/receive antenna array must be in close proximity to the service area.
- 2. The cellular transmit/receive antenna array must have <u>sufficient height</u> to provide line of sight access to the service area.

Electronic Engineer talk: Signal Strength decreases over distance. The decrease is not a linear (straight line) function. Power density (signal strength) is proportional to the inverse square of the distance. That means every time you double the distance you receive only 1/4th of the available power (signal strength). My electronic engineering buddies tell me: "If we measured cell phone signal strength in dollars, the math would go like this: \$100 of signal strength in 1 mile turns into \$25 of signal strength in 2 miles. That same signal strength in 4 miles (double 2 miles) is \$6. At 8 miles (double 4 miles) signal strength is a \$150. At 16 miles (double 8 miles) signal strength is a mere 35¢"



These 2 factors are the only reason that <u>today</u> Verizon provides marginally better service than AT&T in Cedar Key. Verizon's 300' tall antenna array on CR347 by the Scrub is closer to town than AT&T's 300' tall antenna array out on SR24. Proximity to town is the only reason. Neither company is inherently better than the other. Indeed, put an antenna array from Joe's Cell Phone and Pizza Company in downtown Cedar Key, Joe would instantly become the "best" cell phone service provider.

We want to partner with the Cedar Key Water & Sewer District to provide the best possible cellular antenna location in Cedar Key. We're here today to begin that dialogue. I repeat. We are here to begin a dialogue. That's all. We are not here to seek any commitments nor are we delivering any promises.

The scope of this undertaking requires transparency between all the parties involved.

We understand that the District has two potential cellular antenna array sights to offer. The first is the new communications tower slated for construction at the intersection of CR347 and SR24. The second is the centrally located City Water Tower adjacent to Cedar Key School.

From our perspective, the centrally located City Water Tower sight seems superior. Remember that cellular signal strength curve. Compare the proximity of the District's two sights to the service area.

You've heard our thoughts and suggestions. We've openly shared important information. The Cedar Key Water & Sewer District Board needs to do the same. We shouldn't focus our conversation on arbitrary opinions about one antenna location versus another. What this means to the citizens of Cedar Key is, by working together we can develop a plan that yields the most favorable economic return to the District. By partnering citizens and government, we can craft the best overall solution to the challenges of reliable cellular telephone service and broadband internet connectivity for the entire community of Cedar Key. I call on you to join us in meeting those challenges.

# Wireless Substitution: Early Release of Estimates From the National Health Interview Survey, July-December 2018

#### Overview

Preliminary results from the July-December 2018 National Health Interview Survey (NHIS) indicate that the number of American homes with only wireless telephones continues to grow. More than one-half of American homes (57.1%) had only wireless telephones (also known as cellular telephones, cell phones, or mobile phones) during the second half of 2018an increase of 3.2 percentage points since the second half of 2017. More than three in four adults aged 25-34 (76.5%), and a similar percentage of adults renting their homes (75.5%), were living in wirelessonly households. This report presents the most up-to-date estimates available from the federal government concerning the size and characteristics of this population.

#### NHIS Early Release Program

This report is published as part of the NHIS Early Release Program. Twice each year, the National Center for Health Statistics (NCHS) releases selected estimates of telephone coverage for the civilian noninstitutionalized U.S. population based on data from NHIS, along with comparable estimates from NHIS for the previous 3 years. The estimates are based on in-person interviews that are conducted throughout the year to collect information on health status, health-related behaviors, and health care access and utilization. The survey also includes information about household telephones and whether anyone in the household has a wireless telephone.

To provide access to the most recent information from NHIS, estimates using the July-December 2018 data are being

released prior to final data editing and final weighting. These estimates should be considered preliminary. Estimates produced using the final data files may differ slightly from those presented here.

#### Methods

For many years, NHIS has asked respondents to provide residential telephone numbers, to permit the recontacting of survey participants. Starting in 2003, additional questions were asked to determine whether a family had a landline telephone. An NHIS family was considered to have landline telephone service if the survey respondent for the family reported that there was "at least one phone inside your home that is currently working and is not a cell phone." (To avoid possible confusion with cordless


landline telephones, the word "wireless" was not used in the survey.)

An NHIS "family" is an individual or a group of two or more related persons living together in the same housing unit (a "household"). Thus, a family can consist of only one person, and more than one family can live in a household (including, for example, a household where there are multiple single-person families, as when unrelated roommates are living together).

The survey respondent for each family was also asked whether "anyone in your family has a working cellular telephone." Families are identified as "wireless families" if respondents reported that someone in the family had a working cell phone at the time of interview. This person (or persons) could be a civilian adult, a member of the military, or a child.

Households are identified as "wireless-only" if they include at least one



#### Cedar Key Water and Sewer District General Manager Report November 11, 2019

#### 1. Water Plant

The chlorine dioxide pilot test was resumed on October 21 using the Palintest to maintain chlorine dioxide levels in the clearwell. We continue to have challenges with the pilot test which I will report on at the meeting.

We went slightly over on the annual average for THMs this quarter, so the attached notice will be mailed out this week. (29)

#### 2. Wastewater Bridge Lines Directional Drills

Construction has been completed and the final inspection was performed by Mittauer which revealed a few minor issues to be resolved.

#### 3. Downtown Building Painting and Repairs

I continue to wait for quotes and samples for new aluminum railings for the front of the building, and for a location in the WWTP where they are needed for safety.

#### 4. TRIM

We received notification from the State that all TRIM procedures were correctly followed. (30)

#### 5. Cell Service

Surveyors working for Verizon visited the water tower site on November 1 as the next step in coming up with a proposal for antennas on the water tower.

#### What happened?

Our water system did not meet the requirements of a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what happened, what you should do, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Testing results we received from samples taken August 6, 2019, when averaged with quarterly results from the past year, show that our system exceeds the standards, or maximum contaminant levels (MCL), for Disinfection Byproducts (DBPs), which includes Total Trihalomethanes (TTHMs). The standard for TTHMs is 80 micrograms per liter ( $\mu$ g/L). Compliance is based on the locational running annual average (LRAA), which is the average of all quarterly results from the past year.

#### What should I do?

Some people who drink water containing TTHMs in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous system, and may have an increased risk of getting cancer.

Any customers who are concerned about their exposure to DBPs may choose alternative sources of water for ingestion.

#### What does this mean?

This is not an immediate risk. If it had been, you would have been notified immediately.

#### What is being done?

We are testing a change in the primary disinfectant from chlorine to chlorine dioxide as a permanent fix for this problem. We will continue to monitor and report to you by public notice on future testing results.
